Dear Ms. Hirose:

This is in response to your correspondence of June 17, 2014, in which you requested, under the Freedom of Information Law, various records relating to the acquisition and use of cell site simulators or "Stingrays." You specifically identified nine categories of records in your request.

A diligent search of our files failed to locate any records responsive to items 2, 4, 5, 6, 7, 8 and 9 of your request. As for the remainder of your request, enclosed please find one responsive record. Please be advised that certain information responsive to your request is exempt from disclosure pursuant to Public Officers Law § 87(2). Specifically, records have been redacted and/or withheld that would constitute an unwarranted invasion of personal privacy if disclosed (*see* §87(2)(b)); are trade secrets or were submitted to an agency by a commercial enterprise or derived from information obtained from a commercial enterprise and, if disclosed, would cause substantial injury to the competitive position of that enterprise (*see* § 87(2)(d)); were compiled for law enforcement purposes and, if disclosed, would reveal non-routine criminal investigative techniques and procedures (*see* § 87(2)(e)); could endanger the life or safety of any person if disclosed (*see* § 87(2)(f)); and, if disclosed, would jeopardize the capacity of this agency, or another entity that has shared information with this agency, to guarantee the security of its information technology assets (*see* § 87(2)(i)).
