> Re: Freedom of Information Law Request

> > E-ZPass Readers and Automatic License Plate Readers

Dear Records Access Officer:

The New York Civil Liberties Union ("NYCLU") is filing this request for records pursuant to the New York Freedom of Information Law, Article Six of the Public Officers Law, to seek information on the New York City Police Department ("NYPD")'s acquisition and use of Automatic License Plate Readers ("ALPRs"), as well as information on the NYPD's possession and use, if any, of electronic readers that detect drivers' E-ZPass tags ("E-ZPass Readers"). We are concerned that the acquisition and use of these types of technology without proper limitations threatens the right of New York City drivers to privacy in their location and movement.

The NYCLU therefore requests the following records:

- 1. Memorandum from chief of detectives, Phil T. Pulaski, regarding "suggestions for using the department's 398 license plate readers," as reported in the New York Times on February 19, 2013.²
- 2. Documents sufficient to show the number of ALPR units or systems acquired by the NYPD.
- 3. Documents sufficient to show the number of E-ZPass Readers acquired by the NYPD.

- 4. Documents sufficient to show the sources of funds used to pay for ALPR technology and/or E-ZPass Readers in the possession of the NYPD.
- 5. All invoices for the purchase of ALPR technology and/or E-ZPass Readers by the NYPD.
- 6. Documents showing the number of license plates scanned and/or read using APLR technology in a given time period (day, month, year, etc.) since January 1, 2012.
- 7. Documents showing the locations of E-ZPass Readers installed or otherwise in use in New York City, including, if available, information distinguishing readers that are used to collect tolls from readers used for other purposes.
- 8. Documents showing the locations of any stationary ALPR units installed or otherwise in use in New York City.
- 9. Policies, practices and procedures, and training materials for procuring and using ALPR technology, and for storing, accessing and sharing data obtained through ALPR technology.
- 10. Policies, practices and procedures, and training materials for procuring and using E-ZPass Readers, and for using, storing, accessing and sharing data obtained through E-ZPass Readers regardless of whether the E-ZPass Readers are in the control of the NYPD.

If possible, please provide the requested records in electronic format. If requested records are maintained in a computer database, please contact us before retrieving the records so that we can ensure that the retrieved records are in a usable and readable format.

Upon locating the requested documents, please contact us before photocopying and advise us of the actual costs of duplication so that we may decide whether it is necessary to narrow our request.

We would appreciate a response as soon as possible and look forward to hearing from you shortly. Please furnish the requested records to:
