KIMBERLY HURRELL-HARRING, being duly sworn, deposes and says:

- 1. I am a named plaintiff in this case.
- 2. I am 31 years old and live in Rochester, New York, although I am currently in jail in Fort Edward, New York, in the Washington County Jail.
- 3. On the day this case was filed, I had a pending criminal case in Washington County Court. I was represented in that case by the Washington County Public Defender.
- 4. I am a certified nursing assistant, and before I was arrested last September, I worked two jobs so that I could take care of my mom, who is recovering from a stroke, and my daughters, who are four and sixteen.

- 5. On September 29, 2007, I was arrested and charged with introduction of prison contraband in the first degree, a felony, and possession of marijuana, a violation. I was accused of bringing 22.1 grams (around three quarters of an ounce) of marijuana to my husband in jail. He had threatened me into bringing it to him, and he was planning on keeping it for his own use. I faced up to seven year in prison and up to \$5000 in fines.
- 6. The first time I was in court, I did not have a lawyer to represent me at arraignment. Even though I had absolutely no criminal record, the judge set bail at \$10,000 cash or a \$20,000 bond. There was no way that I could get together so much money, and so I was sent to the Washington County jail.
- 7. I met my lawyer for the first time at the county jail soon after I was arraigned. The whole time that we were talking, I felt like he didn't really care about my case, my family, or my future. For over a month, he never returned my phone calls or responded to letters I sent him. I felt like he thought of me as just another case he needed to finish and not as an individual.
- 8. Since I had been accused of bringing such a small amount of marijuana into the prison, and since I had never been in trouble with the law before, I hoped that I could get probation. I wanted to go home, to take care of my mother, to be with my daughters.
- 9. On October 12, 2007, I pled guilty to promoting prison contraband in the first degree. At that point, I still thought that it was possible for my lawyer to help me get a lesser sentence and to get the charges reduced to a misdemeanor. He had not presented me with any alternatives to doing time in jail on a felony. He also had not explained to me the full consequences of pleading guilty.

10. On November 16, 2007, I was sentenced to six months in jail and five years of probation.

I had strongly thought about withdrawing my plea because I thought I should have been

charged with a misdemeanor rather than a felony. I wanted my lawyer to talk to the DA

one more time before sentencing. I waited for my lawyer to come talk to me while I was

being held before my hearing, but he never did. I only found out in the courtroom, at the

defendant's table, that the DA had rejected a request to reduce the charges. Without any

chance to talk to my lawyer about what I could do, I didn't ask to withdraw the plea.

11. As a result of this felony conviction, I will lose my certified nursing assistant license and

my Section 8 housing. I also was planning on obtaining an associate's degree in

phlebotomy or becoming a LPN (license practical nurse). I have worked in the nursing

field for over twelve years, and when I lose my jobs, I don't know how I will support my

family. If I didn't have my mom's house to go back to, my daughters and I would be on

the street.

12. I don't think that my lawyer ever really fought on my behalf for a plea bargain that took

into account the circumstances of my charge, my clean record, and how hard things are

for my mom and kids without me there to work and to take care of them.
