SUBJECT: MILITARY RECRUITMENT DIRECTIVE

The No Child Left Behind Act requires the New York City Department of Education to provide the names, addresses, and telephone numbers of 11th and 12th grade high school students to military recruiters and institutions of higher learning that request this information, except where the parent or student notifies us that he/she does not consent to release of this information. The law also requires that we give military recruiters the same access to 11th and 12th grade students that is generally provided to post-secondary educational institutions and prospective employers.

The following sets forth procedures that schools must follow with respect to opt out letters and military recruitment in the schools. It is important that this memorandum is carefully reviewed and that referenced procedures are followed.

OPT-OUT NOTIFICATION

While we are committed to protecting the privacy of our students, we must comply with the law. Unless a parent or student notifies the Department of Education in writing that he/she does **not** consent to the release of the student's information, we must disclose the child's name, address, and telephone number to military recruiters and institutions of higher learning at their request.

Therefore, the attached letters must be distributed to all parents and students in the 11th and 12th grades. The parent letter must be mailed to the home, and the student letter must be distributed in school between the dates of September 17, 2008 and October 3, 2008.

As of the 2008-2009 school year student information will be provided to military recruiters centrally from the Department of Education during the first week of November, therefore, eliminating the need for individual schools to provide this information directly to recruiters.

Procedures to Follow

Each principal must mail the attached parent opt-out letter to parents, and distribute the attached student opt-out letter to students, according to the following instructions.

• Order parent address labels for ALL 11th AND 12th GRADE STUDENTS through ATS.

 Photocopy on school letterhead the attached PARENT letter and opt-out form and send by first class mail between September 17, 2008 and October 3, 2008 to the parents of ALL 11th AND 12th GRADE STUDENTS.

Photocopy on school letterhead the attached STUDENT letter and opt-out form and distribute **between the dates of September 17, 2008 and October 3, 2008** to ALL 11th AND 12th GRADE STUDENTS. If possible, students should be given time in homeroom or advisory to read the letter and fill out the form if desired. Guidance should be provided to students who request it. Enter the names of students who have opted out and/or whose parents have opted them out into the ATS system. Schools should use the ATS function, UPCO, to enter the opt-outs.

As indicated above, the provision of this information will be centrally disseminated to all branches of the armed forces during the first week of November. Therefore schools should inform military recruiters who directly request student information to contact their supervising officers in regard to the protocol for the procurement of these lists. - Requests from institutions of higher education will continue to be made directly to schools.
 In order to generate this information, schools may use the ROPO Report on ATS. Schools will select the "Report for Institutions of Higher Education" option. Care should be taken to send the appropriate reports, as students may be opted out of either Military Recruiters or Institutions of Higher Learning.
- Schools should designate a staff member who will serve as the point person and who will create a system to ensure that when lists are prepared for either Institutions of Higher Education or Military Recruiters the students who have opted out of each program have been excluded from the appropriate list.
- Students who enroll in either 11th or 12th grade after the letters are mailed to parents and distributed to students must be given the opt-out letters as part of the admission/orientation packet and must be asked to return the forms within two weeks of their enrollment. In addition, the opt-out letter must be mailed to the parents of these students.
- Contact information of students who have not opted-out will be shared with military recruiters during the first week of November.
- THERE IS NO DEADLINE FOR OPT-OUTS. PARENTS AND STUDENTS MAY EXERCISE THEIR RIGHT TO OPT-OUT AT ANY TIME DURING A STUDENT'S SCHOOL CAREER.
- Unless an opt-out form is received, the DOE must provide student contact information on request.
- Opt-out letters may be distributed multiple times during the school year at your discretion.

Recruitment

Federal law also requires schools to give military recruiters the same access to students as is given to other educational institutions and prospective employers. All visitors must follow the procedures in the building safety plan, including signing in and out and holding meetings only in

designated locations. No visitor should be given unfettered access to students in classrooms, cafeterias, gyms, or other areas of the school building. Information about opportunities in the military should be posted in the same manner and same areas that other educational and career information is posted. **Please ensure that classroom time is used only for instruction.** You should generally provide students with information about career, educational, or military opportunities in forums dedicated to that purpose.

A list of "Frequently Asked Questions" (FAQs) has been prepared to assist guidance counselors and college and career offices in addressing students' questions regarding their rights under NCLB with respect to military recruitment in the schools.
