Cross-Border Pattern Analysis

The following provides a rough order of magnitude (ROM) estimate for 24 months of technical support for this program based on estimates associated with a proposal submitted in 2009 to the National Institute of Justice (NIJ) for the Predictive Policing Demonstration and Evaluation grant.

How Federal Grant funds will be Utilized:

Table 1 provides a cost summary broken out by labor, travel, and equipment/software. Dollar values are consistent with budget information previously provided to NIJ. The labor estimate includes typical salaries plus loading costs. Further labor detail is provided in Table 2. Travel detail is provided in Table 3, and Equipment in Table 4.

This estimate is based on the following assumptions:

- 1 full-time project manager for 24 months
- 1 full-time senior analyst for 24 months
- 1 full-time mid-level programmer analyst for 24 months
- I full-time technician to support deployment of sensors, collection of data for 24 months
- Administrative and management support
- Research consultant at \$150/hr to support statistical methodology
- Interns will be hired to provide onsite support to DCJS in coordinating the research and
 evaluation activities for the law enforcement/criminal justice partners, pulling together
 data sources and compiling for analysis, exploratory data analysis in support of the
 requirements analysis and research design, and preliminary GIS and mapping. They will
 also be assigned to on-site duties in Franklin and Onondaga County for data collection,
 survey administration, etc.
- Travel for coordination, data collection, and additional travel for dissemination of plans and results at venues such as the NIJ Applied Technology Conference.
