By letter dated September 15, 2020, the Petitioner filed a request for certain records pursuant to the Freedom of Information Law (FOIL). Said request is e-filed in document #6.

Subsequently, the Petitioner filed an appeal based upon "constructive denial", which was determined by correspondence dated June 3, 2021. Said correspondence is e-filed in document #18.

Upon review of the Petitioner's requested relief a review of the Petitioner's September 15, 2020 request for documents related to Disciplinary Records; Use of Force; Field Interviews; Civilian Complaints; Internal Affairs Unit: Investigative Reports; Diversity in the Ranks; Policies; Training and Collective Bargaining Agreements to the Respondents have not been completely provided pursuant to the Petitioner's request.
